November 2, 2021

The Pledge of allegiance was presented.

This Meeting was Called to Order by Supervisor Al Mohler at 7:00 pm

followed by the pledge.

- **Roll Call:** Al Mohler (Supervisor), April Mowrey (Clerk) ABSENT, Ronda Jonas (Back Up Clerk) Joann Cerka (Treasurer) Shelly Bigelow (Trustee) Wesley Westbrook (Trustee)
- **Public Present:** Jennifer Draper, Terry Garbrecht, Jody LaBarre & Dick LaBarre and David Gladysz.
- **Special Meeting:** Shelly made a motion to accept the Special Meeting minutes, with addition to add in (Cherry Grove being Present and that they were her to voice their discontent to get out of the zoning). Second by Joanne, all in favor, Motion carried
- **Zoning Intent to withdraw:** Shelly stated we have a motion to withdraw on the table and we need to vote. Shelly made a motion to continue with the withdraw on the table seconded by Wesley, Board voted Al - Yes Wesley - Yes Shelly - Yes and Joann - Yes, all in favor, motion carried.
- **Emergency Services:** Al was addressed to bring up to board for Greenwood township to Joining into a contract for an ambulance. We would be joining with other townships (Colfax, Manton, Cedar Creek & Liberty paying \$200.- \$500. For a start up of a new service. Board had a lengthy discussion and decided more information is needed at this time. Shelly Made a motion to table till the next meeting second by Wesley, all in favor, motion carried.
- **Old Business:** Post are now set at the cemetery; they are 10 ft apart. Looks good. Al did the work, and he also drained the water at the cemetery. Shelly made a motion to pay Dale for his invoices for the expense of putting in the posts second by Wesley all in favor, motion carried.
- **New Business:** Internet bill- Shelly stated we do not have to provide internet for a clerk not doing the job. Shelly made a motion to stop paying April internet, second by Wesley, all in favor, motion carried.

- **Snow plowing:** to be done by Tidey Builders for the Greenwood Township Hall for the price of \$45.00 each time. Shelly made a motion to accept the price increase from Tidey second by Wesley all in favor motion carried
- **Resignation:** Al discussed with April to resign, he talked with her a couple days ago. She didn't say when she was resigning. We received no timeline for the resignation; the township needs to be able to pay the bills and get the job done. We have no access to the checks, cards, or the laptop to do her job currently. Shelly brought up a recall, at this time the board decided to see the lawyer and have a letter drawn up for her resignation by December 1st, 2021, and all items return to township. Shelly made a motion to have Wesley go to lawyers' office to start these proceedings second by Joanne all in favor motion carried.
- **Sexton:** discussion on the table to terminate the sexton at this time and have all items returned to township Hall Shelly made a motion to terminate the sexton at this time, have Ronda make a new letter head type the letter and have Dale sign the letter and Mail to Bob *Mowrey*,, second by Wesley all in favor motion carried.
- **Cemetery business:** Al did talk with Carl Swinehart and that issue has been resolved.
- **Treasure Report:** Shelly made motion to accept Treasure report seconded by Wesley, all in favor, motion carried.
- **Bills:** Shelly Made a motion to pay the bills seconded by Joanne all in favor, motion carried.
- **Public Comment:** Al Made a motion to adjourn second by Shelly all in favor, motion carried.
